All Registered Voters Will Receive Ballot in Mail in early October. READ INSTRUCTIONS CAREFULLY, GO ALL THE WAY THROUGH TO END. SIGN YOUR BALLOT, MUST BE MAILED OR DROPPED OFF BY NOVEMBER 3, 2020. *You can return by mail, place in drop box or turn in at voting sites. To vote in person on a machine instead of by mail, you must surrender your ballot at the polling place.*
